

# 2011 FGC Membership Incentive Classifications

## Overview:

- \* New & returning members (> 12 months) pay \$1,000 up front, select from a member classification below and also receive unlimited cart use for the 2011 season. Junior or Senior pay \$500.
- \* All classifications have implicit Dining benefits.
- \* Any member that desires Social benefits (pool, tennis) must be in an appropriate classification for themselves, their spouse or their family.
- \* The term "spouse" is husband, wife or significant other (in a relationship), as listed with the office.

## Classifications:

**Class A Family** - (\$395/mo): All eligible family members have golf, pool and tennis privileges. No change from the current "Class A" description. (spouse and unmarried children under age 26)

**Class A Dual** - (\$355/mo): Member and spouse receive golf, pool and tennis privileges. This membership is intended for a couple with no children. Member children are not eligible for any privileges and cannot be a pool guest of a member.

\*\* Children can golf as an accompanied, paying guest of member - under the existing guest policy.

**Class A Single with Family Social** - (\$345/mo): Golf privileges only for the member. Member and family have pool and tennis privileges. Children are eligible for Junior Sports but are only allowed to golf during pro-supervised Junior Golf program times.

\*\* Spouse or children can golf as an accompanied, paying guest of member - under the existing policy.

**Class A Single** - (\$295 /mo): Golf, pool and tennis privileges only for the member. This membership is intended for a single person, or a situation where the spouse and children do not use the club. Family are not eligible for any privileges other than dining and cannot be a pool guest of a member.

\*\* Spouse or children can golf as an accompanied, paying guest of member - under the existing policy.

**Class C Junior** - (\$198/mo): No change from current Junior plan. Any member under age 37 is eligible for Junior status. The member and family have full golf, pool and tennis privileges.

**Class G Senior Family** - (\$395/mo): Same privileges as Class A Family, but only 8 months dues.

**Class G Senior Dual** - (\$355/mo): Same privileges as Class A Dual, but only 8 months dues.

**Class G Senior Single w/ Social** - (\$345/mo): Same as Class A Single w/ social, but 8 months dues.

**Class G Senior Single** - (\$295 /mo): Same privileges as Class A Single, but only 8 months dues.

**Class B Social** - (\$149/mo): Same privileges as a Class A Family, except for golf. Children are eligible for Junior Sports but only allowed to golf during pro-supervised Junior Golf program times.

\*\* Social members can golf as an accompanied, paying guest of member - under the existing policy.

**Junior / Senior Social** - (\$99 /mo): Same privileges as Class B Social. Any member under age 37 is eligible for Junior status. Any member over age 70 is eligible for Senior status.

\*\* Social members can golf as an accompanied, paying guest of member - under the existing policy.

**Non-Resident** - (\$198 /mo): No change from current Non-Resident class.

## Qualification

**POOL GUEST:** A member of the Flint Golf Club in any classification is not eligible to be a pool guest. For example, if a Dining member wants pool privileges, they need to be in a Social classification. If a Class A Single member wants their spouse or children to have pool privileges, they need to be either a Single w/ Social, Dual or Family classification depending on the benefits desired.
